

SAMPLE CONTRACT FORM
AGREEMENT FOR SCHEDULE PA ELECTRIC SERVICE

Sierra Pacific Power Company ("Sierra Pacific") hereby agrees to supply electrical service to _____ ("Customer"), whose billing address is _____, California, and to permit the customer to take the service known as "Optional Interruptible Irrigation Service" for the electrical service accounts listed on Appendix A, attached hereto and as may be hereinafter amended, in accordance with Schedule No. PA as this schedule now exists or may be hereafter amended or superseded, a copy of which is attached hereto and by reference incorporated herein. Sierra Pacific and Customer desire to set forth the terms and conditions under which Schedule No. PA shall be performed:

Now, Therefore, in consideration of these promises and of the mutual covenants herein, the parties hereto agree as follows:

1. Customer understands and agrees that electric service under Schedule No. PA may be interrupted by Sierra Pacific at any time during the period from March 1 through November 30, inclusive, upon either written or verbal notification by Sierra Pacific that a system emergency exists and load reduction is needed to maintain system integrity.

2. Customer understands and agrees that failure to reduce load upon request by Sierra Pacific will result in the Customer being billed for the Season (March 1 through November 30) at the A-1 rate schedule.

3. Customer understands and agrees that the optional interruptible irrigation rate under Schedule No. PA applies only to electricity used to pump water for agricultural irrigation, and that service under this Schedule No. Pa must be metered separately from other consumption uses; otherwise, Customer does not qualify for the optional interruptible irrigation rate.

4. This agreement shall be in effect for a minimum term of one year from the date of execution. Either Sierra Pacific or Customer may terminate the agreement at any time after the end of this minimum term upon thirty (30) day's written notification.

5. Customer releases Sierra Pacific, its Directors, Officers, and Employees from any and all liability not attributable to the negligence of Sierra Pacific, whether direct, indirect or consequential for damage to Customer whatsoever resulting from or arising out of electric service provided under Schedule No. PA.

6. This contract shall at all times be subject to such changes or modifications by the California Public Utilities Commission ("CPUC") as said CPUC may, from time to time, direct in the exercise of its jurisdiction.

7. Notwithstanding any other provisions of this contract, Sierra Pacific shall have the right to unilaterally file with the CPUC pursuant to the CPUC rules and regulations, an application for a change in rates, charges, classification or service, or any rule, regulation, or contract relating thereto.
