**Sierra Pacific Power Company d/b/a NV Energy Electric Rate Schedules for Residential Customers**

The Public Utilities Commission of Nevada (PUCN) has authorized changes in Sierra Pacific Power Company d/b/a NV Energy rates effective **October 1, 2016**. The following rate schedule shows the actual changes in rates.

NV Energy's rates shown here are in addition to any Local Government Fee based upon revenue or quantity of energy sold. These taxes are imposed upon the utility by the local governments within our service territory.

In addition, the customer will be billed for the Universal Energy Charge of \$0.00039 per kWh of usage, with monies going to the State of Nevada Fund for Energy Assistance and Conservation as set forth in NRS 702.010 to 702.282.

The rates contained in this schedule are for bundled rates. Bundled rates are the combination of all the services necessary (generation, transmission and distribution) to deliver reliable electric power to retail end-use customers. Distribution Only Service is available to certain eligible customers who meet the provisions set forth in chapter 704B of the Nevada Administrative Code.

Summer mid-peak is July 1 – September 30, from 10:01 a.m. to 1:00 p.m. and 6:01 p.m. to 9:00 p.m., Monday – Friday.
Summer off-peak is July 1 – September 30, all other hours, Monday – Friday and all hours, Saturday and Sunday.
Electric Vehicle Recharge Rider (OD-REVR) – Summer, July 1 – September 30 and Winter, October 1 – June 30, 10:01 p.m. to 6:00 a.m.

**HOW TO CALCULATE YOUR BILL**

For a Domestic Service customer on a 30-day billing period (27-34 days is the typical range of billing days), five (5) percent Local Government Fee and 758 kWh usage during the billing cycle:

- a. Basic Service Charge \$ 15.25
b. Electric Consumption: 758 kWh x \$0.08896/kWh \$ 67.43
c. Deferred Energy Accounting Adjustment, 758 kWh x \$(0.00815) kWh \$ (6.18)
d. Temp. Green Power Financing (TRED): 758 kWh x \$0.00099/kWh \$ 0.75
e. Renewable Energy Program (REPR): 758 kWh x \$(0.00026)/kWh \$ (0.20)
f. Energy Efficiency (EE) Charge: 758 kWh x \$0.00181/kWh \$ 1.37
g. Subtotal: a + b + c + d + e + f \$ 78.42
h. Local Government Fee Washoe County .05 x g (varies by political subdivision) \$ 3.92

- i. Universal Energy Charge, 758 kWh x \$0.00039/kWh \$ 0.30
j. Total bill: g+ h + i \$ 82.64

**ADDITIONAL CHARGES**

**Universal Energy Charge:** \$0.00039 per all kWh of usage. Monies go to the State of Nevada Fund for Energy Assistance and Conservation as set forth in NRS 702.010 to 702.282.

**Late Charge:** One (1) percent of any amount in arrears from the previous billing.

**Local Government Fee:** A tax of variable amount as imposed by any political subdivision such as business license fees, gross receipts tax or other similar tax. The Local Government Fee is calculated by the percent of the fee (Washoe County currently is five (5) percent) multiplied by the subtotal of your bill.

**Minimum Charge:** The minimum charge for service is the Basic Service Charge.

**NON-STANDARD METERING OPTION (NSMO)**

Customers may request to have the utility install a non-standard meter (analog meter). Customers requesting this option will be charged an initial one-time fee and an additional per meter, per month fee in addition to all rates and fees contained in the customer's otherwise applicable rate schedule. Certain restrictions and conditions apply.
