SPECIAL CONDITIONS

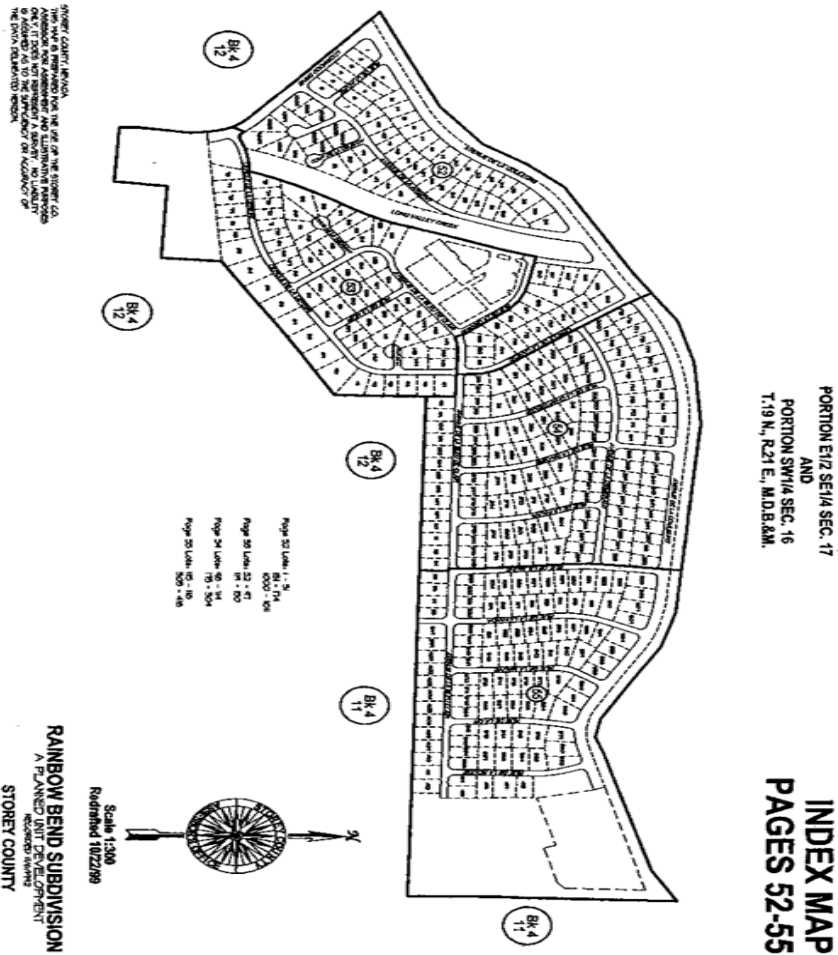
1. **Natural Gas Availability.** Service hereunder will not be provided by the company where natural gas is available or can be reasonably provided.
2. **Service Discontinuance.** Service hereunder is provided on a temporary basis and will be discontinued at such time as natural gas is available in the area.
3. **Propane Service.** Propane service may be provided, at the option of the Utility, in a propane/air mixture.
4. **Line Extensions.** Line Extension costs will be calculated using the provisions of Rule No. 9 of Gas Tariff No. 1. Refunds under Rule No. 9 will be based on theoretical revenues calculated by applying the appropriate rate to therm sales.
