RULE NO. 23
EXAMINATION AND TESTING OF LINES AND/OR EQUIPMENT
WITHIN MOBILE HOME PARKS

A. General Information:

When required by the Commission, the Utility will examine and test the lines and equipment within a mobile home park and report the results to the Commission. Such examination and testing shall include lines and equipment up to the entrance to the mobile homes to determine whether any line and/or equipment is unsafe for service under the safety standards set by the Utility's regulations for maintenance, use and operation of the Utility's facilities.

B. Liability:

The Utility is not responsible for the condition of any systems, line or equipment not owned by it, or for the maintenance or operation thereof.

The Utility is only responsible for (a) conducting the examination and test specified in Section A thereof, (b) reporting accurately the result thereof to the Commission, and (c) promptly executing any order of the Commission directed to the Utility in consequence thereof.

C. Examination and Testing:

1. Any examination and testing of electric distribution lines and/or equipment by the Utility pursuant to this rule shall be conducted at the expense of the customer of the Utility to whom electricity is metered for sub-distribution through the lines and/or equipment owned by the Customer.
2. The Utility's charge for examination and testing shall be the total of the time and equipment charges, with appropriate overheads, accumulated according to the standard accounting practices of the Utility.
