**PUBLIC STREET LIGHTING AND TRAFFIC CONTROL SERVICE**

**APPLICABLE**

To any city, town, unincorporated community, county or state governing body for electric service only to standard installations of luminaries for dusk to dawn lighting of public streets, alleys, thoroughfares, public parks and playgrounds and to electric service only to traffic control signals. After the April, 1984 billing period, the Utility will not accept additional installations under this Tariff where it is necessary to install Mercury Luminaries. Only Customers using High Pressure Sodium Luminaries will be accepted. All of such street lighting and traffic control equipment will be owned, operated and maintained by city, county or state governing bodies.

Entire Nevada Service Area, as specified.
