Sierra Pacific Power Company d/b/a NV Energy Quarterly Electric Base Tariff and Deferred Energy Accounting Adjustment

Effective **July 1, 2017**, Sierra Pacific Power Company d/b/a NV Energy is adjusting its Base Tariff Energy Rate (BTER) and Deferred Energy Accounting Adjustment (DEAA) to reflect changes in energy or purchased power costs the company pays on behalf of its customers. This change will result in a revenue increase of \$26,838,074. Increases or decreases are passed on dollar-for-dollar, with no profit to the company.

The company makes these quarterly filings on May 15, August 15, November 15 and February 15. These adjustments become effective 45 days from the date of filing. The transactions and recorded costs of purchased fuel or purchased power, which are the basis for any quarterly rate adjustment, will be reviewed for reasonableness and prudence in the next proceeding held by the Public Utilities Commission of Nevada to review the annual deferred energy accounting adjustment application.

The chart below reflects the adjustment for the average monthly bill for each customer class. Actual changes to individual customers' bills will vary depending on the level of consumption.
