Effective **January 1, 2021**, Sierra Pacific Power Company d/b/a NV Energy is adjusting its Base Tariff Energy Rate (BTER) and Deferred Energy Accounting Adjustment (DEAA) to reflect changes in energy or purchased power costs the company pays on behalf of its customers. This change will result in a revenue increase of \$59,337,038. Increases or decreases are passed on dollar-for-dollar, with no profit to the company.
