

Sierra Pacific Power Company d/b/a NV Energy Natural and LPG Gas Rate Schedules



The Public Utilities Commission of Nevada has authorized an increase in Sierra Pacific Power Company d/b/a NV Energy Natural Gas and Liquefied Petroleum Gas (LPG) rates effective **April 1, 2023**. The following rate schedule shows the actual changes in rates.

NV Energy's rates shown here are in addition to any Local Government Fee based upon revenue or quantity of energy sold. These taxes are imposed upon the utility by the local governments within our service territory.

RESIDENTIAL NATURAL GAS SERVICE - Schedule RNG

Residential Natural Gas service is applicable to all domestic gas service for space heating, water heating, cooking, air conditioning and other uses. This schedule also applies to churches (chapels other than marriage chapels) and other buildings used for religious worship (provided they are owned and operated by a recognized religious society or corporation other than a religious school).

LIQUEFIED PETROLEUM GAS SERVICE - Schedule LPG

Liquefied Petroleum Gas service is provided only in the Rainbow Bend area and is currently closed to any new service. The Universal Energy Charge and Local Government Fees are not applicable to Liquefied Petroleum Gas rates.

SMALL COMMERCIAL AND INDUSTRIAL NATURAL GAS SERVICE - Schedule SCNG

Small Commercial and Industrial Natural Gas service is applicable to commercial and industrial natural gas customers whose monthly gas consumption is less than 12,000 therms during all of the five (5) winter months, November through March.

LARGE COMMERCIAL AND INDUSTRIAL NATURAL GAS SERVICE - Schedule LCNG

Large Commercial and Industrial Natural Gas service is applicable to large commercial and industrial natural gas customers whose monthly gas consumption equals or exceeds 12,000 therms during one or more of the five (5) winter months, November through March.

HOW TO CALCULATE YOUR BILL

For a Residential Natural Gas customer assuming a 30-day billing period, five (5) percent Local Government Fee and 55 therms usage during the billing cycle:

57 therms x \$ 0.86342 /therm	\$ 49.21
c. Deferred Energy Accounting Adjustment (DEAA)*	
57 therms x \$ 0.17684	\$ 10.08
d. Tax Rate Reduction Rider (TRRR)	
57 therms x \$ (0.01925)	\$ (1.10)
e. Subtotal	\$ 72.20
f. Local Government Fee (varies by political subdivision)	
g. Washoe County x .05	\$ 3.61
h. Universal Energy Charge (UEC)	
57 therms x \$ 0.00330	\$ 0.19

*DEAA is subject to change (increase, decrease or temporary discontinuance) depending on the cost of fuel from suppliers not recovered by the Gas Consumption charge.

**The applicable service charge will be made each time an account is opened, including a turn-on, meter set or reconnection of service or a change in account, and in instances where the customer-requested service calls are not related to problems with utility-owned facilities. When the turn-on, meter set or change of account involves a combination of gas and electric service which is accomplished at the same time, NV Energy will apply a single service establishment charge for all services.

***Before 8 a.m. or after 5 p.m., weekends and holidays or within four (4) hours of request.

ADDITIONAL CHARGES

Late Charge: One (1) percent of any amount in arrears from the previous billing.

Local Government Fee: A tax of variable amount as imposed by any political subdivision such as business license fees, gross receipts tax or other similar tax. The Local Government Fee is calculated by the percent of the fee (Washoe County currently is five (5) percent) multiplied by the subtotal of your bill.

Returned Check Charge: \$10.00 for each check processed and returned by a bank.

Universal Energy Charge (UEC): \$0.00330 per all therms of natural gas usage. Monies go to the State of Nevada Fund for Energy Assistance and Conservation as set forth in NRS 702.010 to 702.280.

Non-Standard Metering Option (NSMO)

Customers may request to have the utility install a nonstandard meter (analog meter). Customers requesting this option will be charged a per meter, per month fee in addition to all rates and fees contained in the customer's otherwise applicable rate schedule. Certain restrictions and conditions apply.

NSMO-1

Per meter, per month. \$ 0.54

NSMO-2

Per meter, per month. \$ 0.53
