#### **ADDITIONAL CHARGES**

**Late Charge:** One (1) percent of any amount in arrears from the previous billing.

**Local Government Fee:** A tax of variable amount as imposed by any political subdivision such as business license fees, gross receipts tax or other similar tax. The Local Government Fee is calculated by the percent of the fee (Washoe County currently is five (5) percent) multiplied by the subtotal of your bill.

**Returned Check Charge:** \$10.00 for each check processed and returned by a bank.

#### **Non-Standard Metering Option (NSMO)**

Customers may request to have the utility install a nonstandard meter (analog meter). Customers requesting this option will be charged a per meter, per month fee in addition to all rates and fees contained in the customer's otherwise applicable rate schedule. Certain restrictions and conditions apply.

**Universal Energy Charge (UEC):** \$0.00330 per all therms of natural gas usage. Monies go to the State of Nevada Fund for Energy Assistance and Conservation as set forth in NRS 702.010 to 702.280.
