### APPLICABLE

This schedule is available as an option to the regular Three-phase Residential Service, non-TOU service under Schedule LRS for Large Residential Service to separately metered, permanent Single-Family Dwellings. This schedule is available to all domestic and other power service that would otherwise be served under Schedule LRS. This schedule is designed to expand and accelerate the development and use of energy storage systems. Customers taking service under Schedule NSMO-1 are not eligible for service under this rate schedule.

# **TERRITORY**

Entire Nevada service area, as specified.

### **RATES**

This schedule contains a Critical Peak Price (CPP) structure overlaid on the base TOU pricing structure of Schedule OLRS-TOU. The Critical Peak Price rate for this schedule only applies when a CPP Event is called. As detailed in Special Conditions 3 and 4, the total CPP Event hours are limited to a maximum of 42 hours per year (12 to 14 events for 3 hours each event from 6:01 PM through 9:00 PM) during the four Summer Season months. Events will only be called on non-holiday days. In exchange for accepting the inclusion of critical peak events and prices during a limited number of days and hours of the Summer Season, Customers serviced under Schedule OLRS-TOU-CPP+DDP are subject to lower on-peak rates (compared to the OLRS-TOU schedule) in each and every hour of the on-peak period during which a CPP Event is not applicable.

In addition, this schedule contains a demand structure. The demand charge rates for this schedule are applied to the Customer's Billing Demand/Time of Use Demand Charge as defined in Special Conditions 5.

In order to fully develop marketing, education materials and tools to help Customers be successful on this rate, this schedule will not be in effect for Customers until October 1, 2018.

The charges applicable to this rate schedule are set forth in the currently effective Statement of Rates and are incorporated herein by reference. Bundled rates can be found beginning on PUCN Sheet No. 10.

# **SPECIAL CONDITIONS**

- 1. <u>UEC.</u> The Universal Energy Charge (UEC), pursuant to NAC 702.150 through 702.450, will go to fund the Nevada fund for energy assistance and conservation. Under certain circumstances, Customers will be refunded amounts paid in excess of \$25,000 per calendar quarter. The Commission will administer the collection of the UEC, certify exemptions, and administer refunds. Exemptions are generally kWh sold to:
  - a) Any governmental agency, including the State of Nevada and any political subdivision thereof, and
  - b) Any Customer using electrolytic-manufacturing processes.

Except as provided above, all kWhs sold are subject to the charge. The UEC is not subject to the charges applicable under the Tax Adjustment Charge.

2. <u>**Time-of-Use (TOU) Periods**</u>. Daily time periods will be based on Pacific Standard Time/Pacific Daylight Time and are defined as follows:

Effective January 1, 2024 Summer Period (June-September) On-Peak 6:01 p.m. – 9: 00 p.m. Daily Off-Peak All Other Hours

Winter Period (October-May) All Winter Hours

The summer period will consist of four regularly scheduled billing periods for service provided in the months of June through September. The winter period will consist of eight regularly scheduled billing periods for service provided in the months of October through May.

- 6. <u>Contract for Service, Minimum Term of Service.</u> Utility shall require a contract for service under this schedule for a minimum term of one year. The contract acceptance may be satisfied through electronic enrollment where available. Upon commencing service under this schedule the Customer shall be required to continue service for a one-year minimum term (twelve consecutive billing periods), unless the Customer moves and terminates electric service at the premise. - 8. **Non-Guarantee.** The Utility is under no obligation to apply this schedule except at the express request of the Customer. The Utility does not guarantee that this schedule will benefit the requesting Customer. The schedule will become effective one full billing cycle after the Customer's request.
- 9. Guarantee. For each residential CPP+DDP Customer completing the one-year (12 billing period) contractual term set forth in Special Condition 7, the Utility will, at the conclusion of the first year of service to that Customer at that premise under CPP+DDP rates, compare (a) the total amount actually paid by the residential CPP+DDP Customer for consumption (i.e., for the metered quantity of kilowatt-hours ["kWh"] used by the Customer) with (b) the amount that would have been paid for the same level of consumption under the otherwise applicable standard residential rate schedule. If the amount paid by the residential Customer for consumption under CPP+DDP rates is higher than the amount that would have been paid under the otherwise applicable residential rate per kWh, the Utility will credit the difference to the Customer's account and request that the Customer inform the Utility if they want to terminate Optional CPP +DDP service. If the Customer responds and requests termination, the Utility will return the Customer to the otherwise applicable standard residential rate schedule.
