

**Schedule No. LCNG**  
**LARGE COMMERCIAL AND INDUSTRIAL NATURAL GAS SERVICE**

**APPLICABLE**

This schedule is applicable to large commercial and industrial natural gas Customers who meet the requirements as set forth in the Special Conditions.

**TERRITORY**

Service hereunder is available in Utility's natural gas service area in Reno and Sparks, Nevada, and their environs.

**RATES**

The charges applicable to this rate schedule are set forth in the currently effective Statement of Rates and are incorporated herein by reference. Rates can be found beginning on PUCN Sheet No. 2H.

**MINIMUM CHARGE**

The minimum charge for service hereunder shall be the Basic Service Charge.

**SPECIAL CONDITIONS**

1. **Service Agreement.** Prior to the establishment of service under this schedule, the Customer may be required to execute a service agreement.
2. **Volumetric Measurement.** The volumetric measurement base hereunder shall be one cubic foot of gas at an absolute pressure of 14.73 pounds per square inch at a temperature of 60° Fahrenheit.
3. **Assignment of Rate Schedule.** For existing Customers, this rate schedule shall be assigned when Customer's monthly gas consumption equals or exceeds 12,000 therms during one or more of the five winter months, November through March. For new Customers, the appropriate rate schedule shall be assigned at the time of the Customer's request for service, based upon his estimated requirements and the applicability sections of these tariffs. Customer assignment to this rate schedule shall be reviewed annually.

- 5. **UEC.** The UEC as mandated by AB 661, passed by the 2001 Legislature, will go to fund the Nevada fund for energy assistance and conservation. Under certain circumstances, Customers will be refunded amounts paid in excess of \$25,000 per calendar quarter. The Commission will administer the collection of the UEC, certify exemptions, and administer refunds. Exemptions are generally Therms sold to: (T)
  - a) Any governmental agency, including the State of Nevada and any political subdivision thereof, and
  - b) Any Customer using such natural gas solely as a source of energy to generate electricity.
 Except as provided above, all Therms sold are subject to the charge. The UEC is not subject to the Tax Adjustment Charge.
