**April 4:** In Docket 16-02006, the Public Utilities Commission of Nevada granted a petition for leave to intervene for Nevadans for Clean Affordable Reliable Energy (NCARE) and denied a petition for leave to intervene for Energy Freedom Coalition of America.

**April 4:** In Docket 14-12028, the Truckee-Carson Irrigation District filed a letter with the Public Utilities Commission of Nevada indicating that due to physical property issues, they would not be able to complete their HydroGenerations project.
