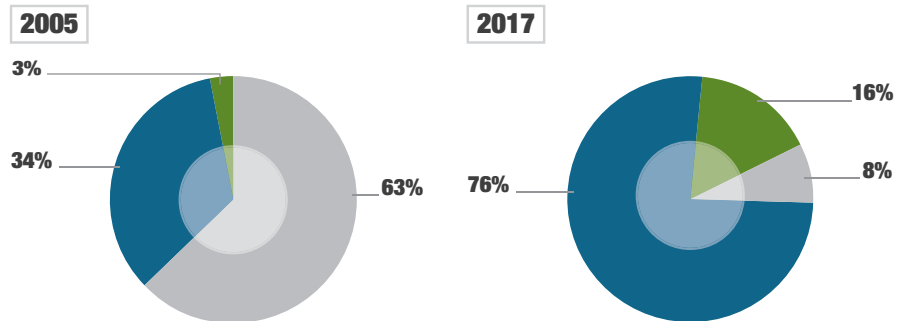




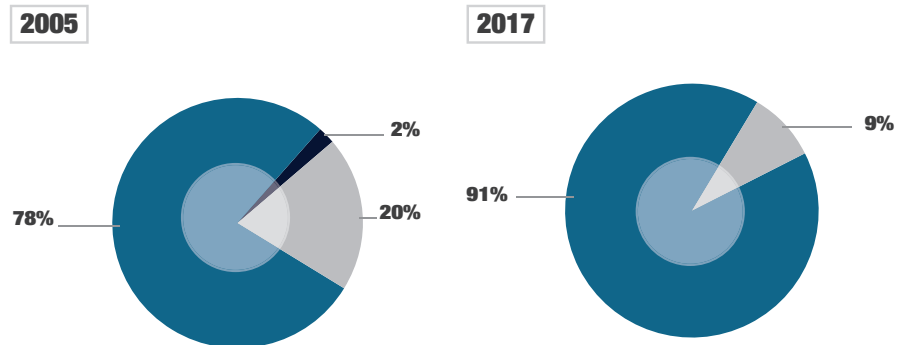
NV ENERGY SUSTAINABILITY REPORT

Net Generation

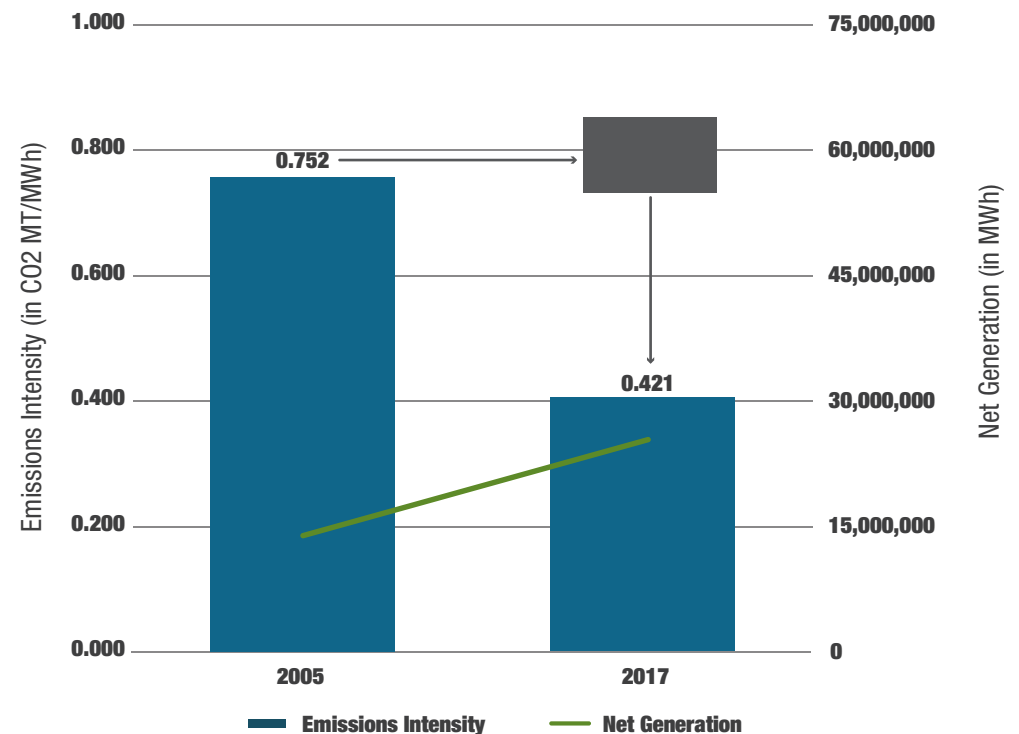


Generation Capacity
