WHAT IS IT?

Cool Credit is a residential program that allows the installation of a receiver switch on your air conditioner. A pager signal is sent to the switch that will turn the unit off for a pre-selected amount of time during summer high-usage periods (usually only 10 minutes out of each half hour between the peak hours of 1-7 pm).



There is **no charge for participating** in the Cool Credit Program. Once your receiver is installed and the size of your air conditioner determined, Nevada Power can calculate your monthly credit.

Minimum credit is \$15 per month. You will receive this credit on your June through September power bills automatically.

TO QUALIFY FOR THE PROGRAM, YOU MUST:

- Own your home, mobile home, or condominium.
- If you rent, you must obtain landlord approval and signature.
- Be a Nevada Power customer in good standing.
- Not have only evaporative (swamp) coolers or window units — qualifying unit must be central air conditioning.

OTHER CONDITIONS

1. Agreement will remain in effect until terminated by either party by giving five (5) days written notice to the other party.
2. Neither party will be liable to the other party for any special consequential, indirect or punitive damages whatsoever. The maximum cumulative liability of one party to the other for any claim arising from or related to the Agreement — whether such a claim is based in contract, negligence or strict liability — will be double the cost of the control unit.
3. I understand if I cancel during the four months the program is in effect, I will be back-billed any credit received in that calendar year.
4. I agree to reasonable access by Nevada Power to the air conditioner unit and to the conditions set forth by the Nevada Public Utilities Commission, as set forth in ORS-LM Rate Schedule (copy available upon request).
5. This program is limited to the first 6,000 new participants.
